



## Placenta Encapsulation Instructor Training Program

### Overview

Woman's Choice Perinatal Services is becoming a known name in the world of placenta encapsulation service and training. We are excited to expand our trainings to different states for potential students who would like a hands on experience. This document will serve as both an informational document as well as an agreement form. By making your payment to enroll in the course, you are agreeing to everything below.

## Course Requirements

As a student, there will be a number of requirements that need to be completed in order to earn your certification to be an instructor. Students must:

- Be a student with at least two completed encapsulations or graduate of the WCPS Placenta Encapsulation Course as an encapsulation specialist
- Be up to date on your Biologix Bloodborne Pathogen Certification
- Complete at least 3 encapsulations during the duration of the course
- Study the course material that you used to become an encapsulation specialist to become confident in your knowledge to successfully simulate the instruction of one class via live video with me (or my assistant) acting as a student. This allows me to ask questions and assess your knowledge. When you are ready to simulate your class, please send an email to book your simulation date and time.
- Send in a headshot along with information about your business and location to be added to the WCPS website on the Our Specialists page
- Send in your completed independent contractor form and W9 within 1 week of completing the course requirements
- Complete the course within 18 months of enrollment. ( You may request a 3 month extension at no cost if needed. You may request an additional 3 month extension beyond the first extension for a fee of \$50.)

## Instructor Agreement

### I. Hosting Location and Responsibilities as an Instructor

Instructors agree not to host encapsulation trainings outside of those that are approved through WCPS. Instructors may not begin their own placenta encapsulation training program for at least 2 years after ending their independent contractor agreement with WCPS. If it is found that an instructor has gone against this, WCPS may seek legal action as this may negatively impact our business. Instructors are responsible for the location of the class, including expenses. This program is best suited for those who already have their own office or are willing to host trainings in their home. Instructors are required to provide WCPS with information about trainings that they wish to host. Training information will be uploaded to the WCPS website upon approval. Students will then book their class through the WCPS website, and you will be informed of the enrolled students at least one week prior to class. You must notify WCPS IMMEDIATELY if you need to postpone a class for any reason by sending an email to

[Womanschoiceps@gmail.com](mailto:Womanschoiceps@gmail.com) and calling the most current phone number provided to you at the time. You are also responsible for notifying your students of the changes. WCPS will promote your classes, but you carry the primary responsibility for attracting students in your area. You must take a photo of each certification that has been distributed during class and email it to WCPS. You are required to do your own sourcing to supply a placenta for each of your classes. You can post ads looking for “placenta donations” on your social media and/or website. Offering something in exchange can be helpful as well. Such as offering a free tincture or offering a gift bag of sample products that you may have received from companies. Be sure to treat your “placenta donation” as you would any other placenta that you work with, by verifying blood work etc. You are required to keep up to date with your Biologix Bloodborne Pathogen Certification. You must send in your updated certification via email upon request. You must renew your independent contractor form and W9 every 12 months or as needed.

## II. Payments

Instructors are not employees of WCPS. Instructors trained through are program are listed as independent contractors. You will receive an independent contractor form and W9 to fill out upon completion of the course. Class cost is \$400 per student. Your compensation will be \$300 per student. You will receive \$150 each time a student enrolls. Once your class has been completed successfully, you will receive a lump sum payment for the remaining student payments that were made. Payments will be made to instructors via check by mail, or PayPal. PayPal is the most convenient method to receive your payment, so I recommend getting an account if you don't have one.

Example of payouts:

5 students enroll in your class. You will receive 5 payments of \$150. Each payment being made within 5 business days of the student enrolling. Once your class has been completed, you will receive one lump payment of \$750 within 2 business days.

## What You Will Receive

Upon completing the program, you will receive:

- Certification that will show that you have successfully completed the training requirements to properly instruct and certify other aspiring specialists
- A one time welcome kit that will provide you with the supplies needed to host a class of at least 5 students. After your one time welcome kit, you will be responsible for obtaining your class supplies. A list of where you can buy supplies in bulk and/or cheap will be provided for you. Supplies are very

inexpensive, as half of them are reusable. Welcome kit will also include a WCPS stamp for certificates. If you lose your stamp, you will be responsible for replacing it.

## Course Fee, Payments, and Refunds

The cost of this course is \$600. Save \$100 when you pay in full with one payment!

We offer the following payment plan if needed:

- \$200 enrollment deposit with monthly payment of \$100 for 4 months. Payments are to be made within 30 days of each other. You may ask for a one week extension up to two times. If you default on your payment after your extension, you risk being dropped from the program with no refund.
